The aim of my enquiry is to gain new insight into how I might support and encourage a sense of social purpose through making & doing activities and workshops created as part of the learning experience for students on the Graphic Branding and Identity course, which support Ual as a social purpose university dedicated to nurturing creativity and deploying it to help solve the world's problems.

What will you be asking participants to do?

- The four UAL staff will be short confidential interviews or respond to a short questionnaire (include draft questions).
- Year 3 students to take part in a focus group (attach a plan/structure for the focus group).
- Year 1 or 2 students to Consent to their participation in a workshop activity being observed and/or documented.

3. How will you get informed consent from these participants?

I will seek consent via a form attached to the interview questions I email by using a checkbox or statement of assumed consent with a link to supporting information. I will state that the information & data I collate is for the purpose of my research and I will ensure there is an option to opt out from their data being used, while still being able to take part in the activity. I will email or given this in person to the focus group I interview and give to the participants of the workshop activity.

4. What potential risks to the interests of participants do you foresee and what steps will you take to minimise those risks? A participant's interests include their physical and psychological wellbeing; their commercial interests; and their rights of privacy and reputation.

There is usually some kind of risk. Is it possible that some participants might find their involvement stressful or embarrassing? Is it likely to raise strong emotions? Are you asking them to give you their time (and more)? Are there any barriers to access or participation for participants? How might you mitigate these risks? Are there any practical considerations of health and safety?
